

RULES AND REGULATIONS FOR MISS MADISON COUNTY FAIR

THE MISS MADISON COUNTY FAIR PAGEANT WILL BE HELD JULY 20th, 2009 IMMEDIATELY FOLLOWING THE MISS TEEN MADISON COUNTY AT THE MADISON COUNTY FAIR GROUNDS, IRVINE ROAD, RICHMOND, KY. FIRST PAGEANT WILL BEGIN AT 7:00p.m. THERE WILL BE FREE ADMISSION AT THE GATE FOR ALL PAGEANT CONTESTANTS. FREE ADMISSION DOES NOT INCLUDE THE CARNIVAL RIDES.

THE MISS MADISON COUNTY BEAUTY CONTEST WILL BE A CLOSED PAGEANT FOR MADISON COUNTY RESIDENTS ONLY. PARENTS MUST BE MADISON COUNTY RESIDENTS FOR AT LEAST ONE YEAR. SPONSOR FEE IS \$50.00 FOR EACH CONTESTANT.

EACH CONTESTANT MUST OBTAIN THEIR OWN SPONSORS. THE SPONSOR WILL RECEIVE ADVERTISEMENT IN THE PAGEANT PROGRAM, PAPER AND WHEREVER THE CONTESTANTS NAME APPEARS. THIS FEE IS TO PAY THE EXPENSES OF THE PAGEANT AND THE FREE TRIP TO THE STATE PAGEANT.

CONTESTANTS MUST BE BETWEEN THE AGES OF 16 AND 21 YEARS OF AGE. CONTESTANTS MUST HAVE REACHED HER 16th BIRTHDAY BY DAY OF PAGEANT AND SHALL NOT HAVE REACHED HER 22nd BIRTHDAY BY OCTOBER 31, 2009.

CONTESTANTS MUST BE SINGLE, NEVER MARRIED, NEVER HAD A MARRIAGE ANNULLED AND NEVER HAD ANY CHILDREN NOR BECOME PREGNANT WHILE REIGNING AS MISS MADISON COUNTY FAIR WINNER. SHE MUST HAVE A GOOD REPUTATION AS SHE SERVES AS A ROLE MODEL TO HER PEERS AND HER COMMUNITY.

THE WINNERS WILL RECEIVE CASH PRIZES, CROWN, SASH, TROPHIES AND FLOWERS. WINNER MUST ATTEND THE FAIR EACH NIGHT FOR THE PRESENTATION OF RIBBONS.

*** ATTIRE WILL CONSIST OF SPORTSWEAR, FORMAL ATTIRE AND THEME ATTIRE DESIGNATED BY DIRECTORS. (USUALLY SHORTS AND TEE SHIRT-TSHIRTS ARE PROVIDED BY THE FAIR). *** THERE WILL NOT BE A SWIMSUIT ATTIRE THIS YEAR. ONLY SPORTSWEAR AND FORMAL WEAR.

*** THIS YEAR THE INTERVIEW AND 1st REHEARSAL WILL BEGIN ON SATURDAY THE 18th AT 11:00 a.m. UNTIL 3:00 p.m. AT THE FAIR GROUNDS. FOLLOWING ON SUNDAY AT 1:00p.m UNTIL 3:00p.m. WE WILL HAVE A 2nd REHEARSAL.

FAILURE TO ADHERE TO THE ABOVE RULES WILL RESULT IN REMOVAL OF THE TITLE, CROWN, SASH AND TROPHY OF WINNER AND INELIGIBILITY TO COMPETE IN THE STATE PAGEANT AND REMOVAL OF ALL RIGHTS TO PARTICIPATE AS QUEEN OF MADISON COUNTY FAIR.

*** PLEASE SEND SPONSORS FEE AND A CURRENT PHOTOGRAPH WITH APPLICATION (NO SNAPSHOTS PLEASE). PHOTOGRAPH WILL BE RETURNED. APPLICATIONS MUST BE RECEIVED BY JULY 15th. HOWEVER IN ORDER TO GET PICTURES INTO THE RICHMOND REGISTER PAPER, PICTURES AND APPLICATIONS MUST BE RECEIVED BY JULY 1st.
