

PRE TEEN RULES AND REGULATIONS

THE MISS PRE-TEEN MADISON COUNTY FAIR PAGEANT WILL BE HELD MONDAY JULY 19th AT 7:00 p.m. AT THE MADISON COUNTY FAIR GROUNDS, IRVINE ROAD RICHMOND, KY. THERE WILL BE FREE ADMISSION AT THE GATE FOR ALL PAGEANT CONTESTANTS. FREE ADMISSION DOES NOT INCLUDE THE CARNIVAL RIDES.

THE MISS PRE-TEEN PAGEANT IS A CLOSED PAGEANT. ONLY MADISON COUNTY RESIDENTS MAY PARTICIPATE. NO EXCEPTIONS.

ENTRY FEE IS \$35.00 (THIS INCLUDES A FREE TRIP TO THE STATE COMPETITION) AND EACH CONTESTANT MUST OBTAIN THEIR OWN SPONSOR. THE SPONSORS WILL RECEIVE ADVERTISEMENT IN PROGRAMS, NEWSPAPER OR WHEREVER THE CONTESTANTS NAME APPEARS. THIS AGE GROUP, PARENTS MAY SPONSOR.

CONTESTANTS MUST BE BETWEEN THE AGES OF 8 AND 12 YEARS OF AGE AND PARENTS MUST BE PERMANENT RESIDENTS OF MADISON COUNTY FOR AT LEAST ONE YEAR. CONTESTANT MUST BE 8 YEARS OF AGE ON JUNE 30, 2010 AND CANNOT BE 13 ON OCTOBER 31, 2010

CONTESTANTS MUST BE SINGLE, NEVER MARRIED, NEVER HAD A MARRIAGE ANNULLED AND NEVER HAD ANY CHILDREN NOR BECOME PREGNANT WHILE REIGNING A MISS TEEN MADISON COUNTY. SHE MUST BE OF GOOD REPUTATION AS SHE SERVES AS A ROLE MODEL FOR HER PEERS AND HER COMMUNITY. SHE MUST ALSO ATTEND THE FAIR EACH NIGHT TO DO PRESENTATION OF RIBBONS AT FAIR EVENTS.

FAILURE TO ADHERE TO THE ABOVE RULES WILL RESULT IN REMOVAL OF TITLE, CROWN, SASH AND TROPHY OF WINNER AND INELIGIBILITY TO THE STATE CONTEST AND ALL RIGHTS TO PARTICIPATE AS TEEN QUEEN OF MADISON COUNTY FAIR

PRIZES WILL CONSIST OF CASH, CROWN, SASH, TROPHY AND FLOWERS. WINNER WILL ALSO GO ON TO THE STATE PAGEANT AT THE FALL MEETING OF THE KENTUCKY FAIR SHOW AND FAIR CONVENTION.

ATTIRE WILL BE SPORTSWEAR, (SHORTS, TOP, ETC) AND DRESSY DRESS (CHURCH TYPE DRESS). NO FORMALS OR PARTY DRESSES WILL BE ACCEPTED.

QUEEN WILL BE REQUIRED TO ATTEND FAIR ACTIVITIES TO PRESENT RIBBONS TO WINNERS.

***REHEARSAL WILL BEGIN ON SUNDAY THE 18th AT 1:00pm. UNTIL 3:00 p.m. AT THE FAIR GROUNDS. INTERVIEWS WILL BE ON MONDAY JULY 19th 1:30-5:30. PAGEANT WILL BEGIN AT 7:00

FAILURE TO ADHERE TO THE ABOVE RULES WILL RESULT IN REMOVAL OF TITLE, CROWN, SASH AND TROPHY OF WINNER AND INELIGIBILITY TO THE STATE CONTEST AND ALL RIGHTS TO PARTICIPATE AS TEEN QUEEN OF MADISON COUNTY FAIR

*** PLEASE SEND SPONSORS FEE AND A CURRENT PHOTOGRAPH WITH APPLICATION . PHOTOGRAPH WILL BE RETURNED.THE APPLICATIONS MUST BE RECEIVED BY JULY 14th. HOWEVER IN ORDER FOR THE PICTURES TO BE IN THE RICHMOND REGISTER THE APPLICATIONS MUST BE RECEIVED BY JULY 5th.
